- Protection to Building Property: Nothing shall be pasted on, tacked, nailed, screwed or otherwise attached to columns, walls, floors, or other parts of the building or furniture. Exhibitors violating this regulation are expressly bound, at their expense to repair any such damage that they may cause.
- The Trade Booth Occupant agrees to assume all liability for damages to property, person or persons arising from accidental or other cause if incidental to movement and operation of the Trade Booth and hereby release the Cape Breton Partnership and the facility from any liability.
- Booth set up: You will be contacted with a scheduled time that you can begin setting up your booth if you wish to set up before Wednesday, May 14, 2025, if the venue is able to accommodate the request.
